EXECUTIVE DEPARTMENT REPORTS:

<u>Councilwoman Albanese</u>: People have expressed their appreciation that the parks have been reopened. She has visited Burrell Lake Park and Kotecki Park and has not seen any issues. People have been courteous on the trails and social distancing guidelines are being followed.

<u>Councilman Fabry</u>: Reported he has reviewed the revenues for year to date and is satisfied with how we have reduced extraneous spending. He will continue to work with Treasurer Eshbaugh and City Administrator Rockwell to keep on top of collections. Discussed the need for a second quarter newsletter and will work with the City Administrator to get it done.

<u>Councilman Grillo</u>: Discussed firefighter funding and tax credits. Discussed his desire to recognize life members of the fire departments, including the departments which are no longer active.

<u>Chief John Marhefka</u>: He reported on the number of incidents, accidents, arrests, traffic citations issued, non-traffic citation issued, warnings, and mileage log.

City Administrator Rockwell: Reported on the results from the Materials Bid and the 2020 Paving Bid. Welcomed Todd Giammatto to the City and reported on his progress. Work continues on the 2020 audit which is taking longer due to COVID 19 restrictions and the auditor is working remotely. Data needs to be scanned and sent. The Act 205 Actuarial Valuation Reports are completed every two years for our pension plans. The report for 2019 has been prepared by Joe Duda and PMRS and submitted to the state for review. Summer helpers for the parks and streets started work today. Urged people to complete the 2020 Census as a lot of our funding sources rely on this data when considering grant awards and various state allocations to municipal and school districts. Prepared and submitted a financial analysis to Councilman Fabry and Treasurer Eshbaugh estimating revenue shortfalls and unexpected expenses due to COVID 19. Discussed staffing and park rentals.

Solicitor Rushford: Provided information regarding parks and facilities reopening guidance.

Treasurer Eshbaugh: Reported on revenues received in the general and sewer fund.

Controller Farina: No report.
